- 5. Passport (2 copies) for Non-Thai applicants
- 6. Four (1x1 inch size) photographs (formal attire, not in graduation gown)

QUALIFICATIONS FOR ADMISSION

- 1. A minimum CGPA of Bachelor's Degree is 2.00 on 4.00 scale with 180 ECTS credits.
- Adequate undergraduate training to do graduate work in the M.B.A. Program
- 3. Good command of English
- 4. Computer literacy
- Student must obtain the CGPA for AU-MBA or AU-MS.MGT of at least 3.00 to study at Hochschule der Wirtschaft für Management, Germany.
- 6. Eligibility for a student visa to study in Germany
- 7. Proof of good knowledge of English by the following certificates:

(For NON-AU graduates)

- TOEIC at least 685 or
- TOEFL internet based at least 79 points or
- IELTS at least 6.0

(For AU Graduateds

- Pass Score 70% of AU English Proficiency Standard Test or having completed AU English IV

EXEMPTION

The English entrance examination can be exempted depending on which of the following conditions you satisfy.

- a TOEFL score of (iBT) 90 or (PBT) 575 or an IELTS (Academic) score of at least 6.5 (Validation: Two years)
- a Bachelor's degree or a higher degree from native English speaking countries (e.g. USA, Canada, UK, Australia and New Zealand)
