Assumption University is a non-profit institution administered by the Brothers of St. Gabriel, a worldwide Catholic religious order, founded in France in 1705 by St. Louis Marie De Montfort, devoted to education and philanthropic activities. The congregation has been operating many educational institutions in Thailand since 1901.

- 1969 Assumption Commercial College in 1969 as an autonomous higher education institution under the name of Assumption School of Business.
- 1972 Official approval by the Ministry of Education and established as Assumption Business Administration College or ABAC.
- 1975 accredited by the Ministry of University Affairs.
- 1990 Granted new status as "Assumption University" by the Ministry of University Affairs.

## DOUBLE DEGREE PROGRAMS

Assumption University is recognized for its academic excellence in countries such as the US, UK, Australia, France, Germany, Poland, the Netherlands, China, South Korea, Japan.

Assumption University graduates have been admitted to top universities across the globe, on either a full-time study basic or as visiting exchange scholars. Many students upon graduation have been placed in highly reputed multinational and global businesses, in addition to serving on national and international trade advisories.

## ADVANTAGES

A double degree enables students to study TWO degree one after another within 5 or 6 semesters.

Students will graduate with different master degrees: an MBA or MS from AU, plus one degree from an overseas partner university.

## JOINT PROGRAM WITH OVERSEAS UNIVERSITIES

As for joint programs, students may study foundation courses leading to the Master' degree offered by the partner universities for 1-2 semesters at AU and then study full-time for another 1-2 semesters at overseas partner universities. The students will be awarded the degree by the partner universities after satisfactory completion of the course requirements.

## DEGREES

- The University offers a wide range of graduate courses and research degrees ranging from 1.5 to 3 or more years in length.
- The medium of instruction for all programs is English.
- There are Full-time and Part-time programs.
- Program duration: 1-2 years for Master Programs and 3 years for Doctoral program studies
- All programs are accredited by the Thailand's Commission of Higher Education, Ministry of Education.

## ADMISSION REQUIREMENTS TO GRADUATE STUDIES

Each Graduate program has its own specific admission requirements but generally all Graduate Studies require applicants to have:

- A Bachelor degree from an accredited institution to apply for Master program
- A Master degree from an accredited institution to apply for Doctoral program
- A cumulative grade point average of 2.0 or its equivalent
- Good command of English
- Computer literacy
- Take the university English proficiency test (or a TOEFL score of (iBT) 90 or an IELTS (Academic) score of at least 6.5 (Validation: Two years)
- Interview entrance examination
